1. Company Overview

Sterling SEZ & Infrastructure Limited (SSIL) is engaged in the Infrastructure and Real Estate sector. SSIL has one of the largest multiproduct Special Economic Zones near Jambusar in Bharuch District, Gujarat. The SEZ has been notified vide Notification dated 9th January, 2008.

2. Initiation of CIRP process and Appointment of Interim Resolution Professional/ Resolution Professional.

SSIL's credit facilities are currently classified as non-performing assets by lenders for defaulting on its debts service obligation.

Hon'ble National Company Law Tribunal, Mumbai Bench by its order dated 16th July, 2018 ("Order"), ordered the commencement of corporate insolvency resolution process ("CIRP") in respect of SSIL under the provisions of the Insolvency and Bankruptcy Code, 2016 and subsequent amendments thereof ("IBC") and appointed Mr. Vishal Jain as Interim Resolution Professional. Pursuant to the Order dated 11th October, 2018 and in accordance with section 22 of the IBC, Mr. Manoj Kumar Agrawal an insolvency professional (bearing IP Registration number IBBI/IPA-001/IP-P00714/2017-18/11222) has been appointed as the Resolution Professional ("RP") in the place of Mr. Vishal Jain (Interim Resolution Professional). In accordance with section 17(1)(b) read with section 23(2) of the IBC, the powers of the board of directors of the Company are suspended and such powers were vested with the RP from the date of the Order. The Resolution Professional has constituted the CoC in accordance with the provisions of IBC and as per directions of the CoC is inviting Expression of Interest ("EOI") from prospective Resolution Applicants ("Resolution Applicants") to submit Resolution Plans in accordance with the provisions of IBC read with Insolvency and Bankruptcy Board of India

(Insolvency Resolution Process for Corporate Persons) Regulations, 2016 ("CIRP Regulations").

3. Process Stages

- Publication of Form G.
- Submission of EOI by Prospective Resolution Applicants ("RAs").
- Submission of the Annexures and relevant documents alongwith EOI for eligibility.
- Opening of EOI & Issue of Provisional List of RAs & communication of objections, if any.
- Submission of objections to provisional list
- Communication of confirmation to shortlisted RAs along with the timelines for process.
- Signing of confidentiality undertaking by the shortlisted RAs as provided by the RP.
- Request for Resolution Plan ('RFRP') outlining the next steps along with the evaluation criteria.
- On signing of the confidentiality undertaking the shortlisted RAs will be provided with the Information Memorandum prepared as per provisions of the IBC
- Access to the data-room to be provided for limited due diligence to shortlisted eligible entities.
